The cost for each display table is \$225 (plus \$25 if an electric hook-up is needed). The rental costs includes a sponsorship for the reception food and open bar. A reception sponsorship without a display table is \$150. Tables will be assigned on a first-come, first-assigned basis.

Each display and demonstration table is six feet wide by 30 inches deep. If your exhibit is large, you may wish to consider ordering a double or triple space.

The display table fee does not include the attending individuals' Conference Registration. Everyone attending must also be registered for the conference. This fee is to cover the food and banquet charges for each individual manning the booth.

During the reception on Thursday evening, food and the open bars will be located in the exhibit area. The banquet will be held following the reception.

Setup for tables begins at 8:00 a.m. on Thursday, January 28. Tear down is after 12:00 p.m. on Friday, January 29. We are asking that you not tear down your exhibit before noon on Friday. We would like to maintain a professional trade show floor throughout the exhibit times.
